

Twinning Programme 2017/18 – call for municipalities Selection and matchmaking criteria

Selection Criteria:

The evaluations of application will be based on the following criteria, which will be ranked through a scale of 0 to 3 (Annex 1). These criteria will include:

For all participants:

- Overall quality of the application
- Being a member of or committed to joining the Covenant of Mayors for Climate and Energy, with a priority for applicants that did not participate in previous twinning programmes
- Evidence that the twinning exchange will help applicants achieve their energy and climate goals for 2020 or 2030 (e.g. clear proposed themes and objectives for the exchange; wellidentified outcomes and added value)
- Evidence that the applicants can dedicate appropriated resources and staff to the twinning exchange

For Peers and learners:

• Willingness to involve relevant stakeholders when hosting an exchange

For Mentors

- Level of advancement in adaptation and mitigation measures
- Level of ambition of their climate and energy plans/strategy

Matchmaking Criteria

- Socio-economic and institutional context (e.g. population size, resources)
- Nature of climate hazards faced
- Preference in participating in a mentoring or peer-to-peer exchange
- Stage of mitigation and adaptation work (e.g. implementation, design phase)
- Interests in sectors/areas of intervention
- Preferred time slot to organise twinning visit
